MPC continues to encourage and support funder collaborations in early childhood, education, oral health and immigrant/refugee communities while also serving as the fiscal agent for the Environmental Funders Network (EFN). These groups exchange information, explore new ideas and consider joint/aligned funding opportunities. This year, EFN supported programs on climate change, aquaculture, and sponsored a funder tour of the Katahdin Region.
