

GIVING IN MAINE

2011 Update of Foundation & Individual Giving


Reflects most recent data available

Each year, foundations and generous individuals provide millions of dollars of support for nonprofit organizations that strengthen the lives of Maine residents and their communities. The data in this report highlights the difficult economic times for the country and the state. While Mainers remain generous, there has been a decrease in both individual and foundation giving since the last report. As part of the Maine Philanthropy Center's commitment to promote philanthropy, we have collected and analyzed the most recent data available to compile this updated summary.

Foundation Giving 2009

- In 2009, there were 327 foundations registered in Maine, reporting \$1.7 billion in assets and \$127 million in grants.
- Since 2000, Maine Foundation assets have increased more than 200% and giving over 300%. There was a 10% decrease in Maine foundation assets this past year, but giving decreased by only 6%.
- While generous in supporting state priorities, Maine foundations give a fraction of the money spent each year by state government. For instance, the Maine Department of Health and Human Services budget for 2009 was \$3.3 billion. Total Maine grants equal only 3.8% of that budget enough to operate the department for 14 days.
- The Top 20 Maine Foundations have seen a decrease in total giving by 21%, but a greater portion of their giving is coming to the state of Maine - an increase of 9%.
- National foundations contribute significantly to Maine nonprofits. Five of these Robert Wood Johnson Foundation, S&G Foundation, Inc., Bank of America Charitable Foundation, Jane's Trust and the David and Lucille Packard Foundation gave \$11 million to Maine in 2009, adding to the \$52 million awarded in Maine by the state's 20 largest foundations.

A Generous Maine

Individual Giving 2008

- Giving by Maine individuals in 2008 reflects the dramatic downturn in the economy the same year.
- 147,713 Mainers reported \$402 million in charitable contributions -- down by 16% since 2007.
- Fewer Maine income tax returns included charitable contributions (23%), below the national average of 27%.
- Among these itemizers, the average charitable deduction was \$2,719 compared to the national average of \$4,343.
- The average Maine deduction is down 11% since 2007 compared to a 6% drop nationally.
- Maine's average giving is consistent with other New England states which tend to rank lower than other regions of the country. Maine is flanked by New Hampshire and Vermont in the current rankings.
- Combined individual giving and charitable bequests account for 80% of all charitable giving in the state.

Charitable Bequests 2008

- In 2008 117 estates of \$2 million or more were settled in Maine for a total of \$73 million.
- The average estate was \$4.2 million and the average charitable beguest was over \$2 million.
- Maine ranked 3rd in the country for estates that included charitable bequests, a significant change from 2007 when Maine ranked 48th.
- Because few estates are settled in Maine each year, trends are difficult to establish, and one or two large bequests may cause Maine's rankings to fluctuate.
