GIVING IN MAINE

2013 Update of Foundation Giving


Reflects most recent data available

Each year, foundations and generous individuals provide millions of dollars of support for nonprofit organizations that strengthen the lives of Maine residents and their communities. As part of the Maine Philanthropy Center's commitment to promote philanthropy, we have collected and analyzed the most recent data available to provide a snapshot of giving in Maine.

Foundation Giving 2011

- In 2011, there were 327 foundations registered in Maine, reporting \$2.5 billion in assets and \$149 million in grants. This represents a 9.5% increase in assets and 10% increase in grants over 2010. In the last five years the foundation community has increased their asset base and their giving totals by 25%.
- Since 2000, Maine foundation giving has increased over 200%, more than double the increase nationally.
- While generous in supporting state priorities, Maine foundations give a fraction of the money spent each year by state government. For instance, the Maine Department of Education expenditures for 2011 was \$1.4 billion. Total Maine grants equal 11% of that budget – enough to operate the DOE for less than 39 days.
- The Top 20 Maine foundations in 2011 increased their giving by over 40% with an increase in asset base of 5%. There was also a shift of giving dollars from Human Services to Health Care, Public Benefit, and Education.
- National and regional foundations contribute significantly to Maine nonprofits. Five of these – Doree Taylor Charitable Foundation, C.F. Adams Charitable Trust, Jane's Trust, Nellie Mae Education Foundation, and Jessie B. Cox Charitable Trust– gave close to \$6 million to Maine in 2011, adding to the \$77 million awarded in Maine by the state's Top 20 largest foundations.
